1.9 Scope OF WORK

1.9.1 AIRCRAFT MAINTENANCE

FLT's CAR 145 scope of work is detailed below. FLT, within its scope of approval on the company, will perform the following:

- Defect rectifications within the personal authorization scope of available personnel, tooling, and equipment.
- AD/SB or minor modifications encompassing physical inspections, operational and functional checks, and replacement of components.
- Non-complex out-of-phase (OOP) scheduled maintenance tasks within the scope of line maintenance.
- NAV DATABASE and TERRAIN DATABASE UPDATES as released and due.
- Pre-flight, Daily & Weekly (or equivalent) inspections as detailed in the relevant AMP.

- L5: Maintenance as defined in the application submitted to the GCAA.
